







During this time "Altruism Society Honour Assistance" (AsHA) initiative emergency Teaching support for lower pre-primary level



students at Habrubil areas under the gossaigaon development block in kokrajhar dist. So we create three groups with about more than fifteen students and each group five student.

- ii. Development of learning level.
- iii. To generate awareness and sense of responsibility among the mass on importance of child education.

Generally, the students of pre-primary and class we are covered under this program. In such centers the children are provided scope of leaning through caring, loving and nurturing environment with completely joyful mechanism. The children learn sound consciousness, concept of mathematics, numbers, letters, words, rhymes etc. This program was run from 1<sup>st</sup> June to 31<sup>st</sup> November 2020.

## LIVELIHOOD PROMOTION

## Farm Based Livelihood.

AsHA objective in engaging in Livelihood Promotion is to enhance food security of the households by adoption of SRI Principle's increasing yield by 1.5 to 2 times. Also enhance case income of target families by Rs 25,000 to 30,000/- additionally, through intensive vegetable farming, livestock rearing as well as enterprise like vermi compost production.



### System of Rice Intensification (SRI) Cultivation organic method

The System of rice intensification involves cultivating rice with as much organic manure as possible, starting with young seedlings planted singly at wider spacing in a square pattern and with intermittent irrigation that keeps the soil moist but not inundated, and frequent inter cultivation with weeder that actively aerates the soil.

SRI is not a standardized, fixed technological method. Its rather a set of ideas, a methodology for comprehensively managing and conversing resource by changing the way that land , seeds, water, nutrients and human labour are use increase productivity from a small but well-tended numbers of seeds. We the AsHA organization in the years SRI cultivation done with 100 nos women SHG farmers.

## Nutrition Garden (NG), Organic Method

Assam is an agro-based state; more than 80% people live in villages. They are mostly poor. Most of the people have only home state. They have only agricultural labour to invest. These people spend most of the time in a year without getting any work. As a result, during these periods they do not have any scope of earning. 50 % of total population in this state are women. They are less educated, unskilled and do not have any access to income generating activities. They get



less food. The effect of extreme poverty falls most severely upon them and their children. About 90% children under 5 years of age in our state suffer from nutrition deficiency. 70% of the population leaving in a below poverty line (BPL) they have suffer from nutrition deficiency. We the AsHA org. will be starting nutrition home garden for they are health improvement also alternative livelihood support

The transplantation of Nutrition Garden started from the month of 20<sup>th</sup> October 2020. Target area for each beneficiary (SHG members) is around 0.25 bigha or less. Before the all process of Nutrition Garden like spec maintains, how to land preparation, using fertilizer, how to transplant etc clearly described after the on field N.G transplantation has been with our farmers. We the AsHA organization in the years NG cultivation done with 50 nos women SHG farmers.

## Maize Cultivation:

Assam's economy is fundamentally based on agriculture. About 89 per cent of state's population of about 3 cores lives in rural areas and about 70 per cent of the total work force is engaged in agriculture and allied activities. Maize is the third important cereal crop in the world after wheat and rice with respect to area and production. India is the fifth largest producer of maize in the world, contributing 3% of the global production,



though productivity is much lower than other potential maize growing countries like USA, Argentina and China. In Assam, maize is the second most important crop, next to rice and is mostly grown under rain fed hilly upland conditions.

Maize is presently the crop with growing importance in the state. Earlier it was primarily grown for human consumption only. In view of rapidly increasing demand of poultry feeds and fodder in Assam it is having more use presently in some small industries. It is the raw material for most of the feed industries. We the AsHA organization in the years Maize cultivation done with 50 nos women SHG farmers.

Through home visit program the we were assigned to do door to door home visit for direct interaction with the parents who were encouraged to look after their children sincerely and take education as major responsibility also discussion sustainable livelihood purpose. ### **COVID19 RELIEF RESPONSE**



Due to present lock down situation ,migrant labour ,daily wages earner ,petty businessmen other poor section are being hit the hardest and the situation is worsening day-by-day as they are caught in a vicious cycle of no jobs, no food and no solution in the near future. With many businesses and government services closed, there is limited access to support services. Police blockades and a lack of public transport are also making it difficult for ration and essential supply. This will prevent the most vulnerable and elderly in the area from going hungry during the


pandemic. Essentials commodities like ration, medicines and daily hygiene products already difficult to access, the lockdown has further reduced their ability and opportunity to procure these items.

In present lockdown situation the organization also come forward to provide ration among the daily wagers, homeless and other people affected by the lockdown imposed in the district of Kokrajhar in view of the corona virus pandemic. Under such circumstances organization had the support COVID 19 Relief response more the 200 thousand needy families, also 10 or more medical supported at pandemic session.


